#### **NECESSARY COOKIES**

Necessary cookies help make our website usable by enabling basic functions like page navigation and access to secure areas of the website. The website cannot function properly without these cookies. These cookies do not collect any personal information about you.

Examples: detection of the type of your device, the screen resolution of your device, the font size you are using.

#### SOCIAL MEDIA COOKIES

Social Media cookies are used to optimise the integration of social media on our websites. They allow our visitors to like or share our content on social media.
